



- 15-page proposal, up to €3 million (indicative), consortium of minimum 3 partners from 3 EU / associated countries
- Deadline: 13 May 2020

FET Proactive Environmental Intelligence

Stimulate the emergence in Europe around the emerging paradigm of **environmental intelligence**

Two complementary sub-topics:

2020 18 M€

- new techniques for creating and using dynamic models of environmental evolution
- radically novel approaches to resilient, reliable and environmentally responsible in-situ monitoring
- Projects up to €4 Million, up to 4 years
- 30-pages proposal, Minimum 3 partners from 3 EU / AC
- Deadline: 22 April 2020



- Individual SMEs with high-risk, high-growth potential aimed at creating new markets
- Substantial funding for the last stages of development
- Bottom-up: all sectors, products, services, new business models
- Optional mixed financing: Grant and Equity (Quasi-Equity & Equity through the EIC Fund (EICF)
- Supported activities:
 - Grant (0,5 2,5 Mio €): trials, prototyping, validation, demonstration and testing in real-world conditions and preparation for market entry (TRL 6-8)
 - Blended Finance (up to 15 Mio €): Market entry and deployment (TRL 9)
- Next deadlines: 08 January, 18 March, 19 May, 07 October 2020

Blended Finance

- Equity: 0,5 15 Mio €
- Ticket: 0,5 Mio € 5 Mio €, payment in tranches
- Actively screening and looking for Co-Investors
- With Co-investors, application of Convertible note
- Commission equity shares between 10 25% if any coinvestors involved, but silent investor
- Exit after 7 10 years (health topics: up to 15 years)

Non-Bankability Criteria

- inability to attract sufficient funding
- relates to the risk profile of the investment
- Part of the Due Diligence process
- The company might be bankable, while the project should be nonbankable
- Proof of non-bankability must be delivered by proposal submission as annex

If the level of risk is high, the project will be deemed non-bankable and therefore be supported by the EIC Fund.

Accelerator Pilot – Co-investors

- EIC Fund looks for potential co-investors (Web-Platform)
- Co-Investors: private or public banks, VCs, etc.
- Investors outside EU are also welcome
- If Exit of a co-investor, the equity shares of the EC might increase
- Founders keep the lead



- Grant-only, Bottom-up
- Consortia of 3-5 from 3 EU / AC —*mandatory industry involvement*,
 Up to €3 million
- Next deadlines: 19 February, 09 June, 27 October 2020
